

Continuing Education Requirements for Montana Licensed Professional Counselors (And How to Stay on Track)

As a licensed professional counselor (LPC) in the state of Montana, it is your responsibility to adhere to continuing education requirements each period in order to renew your license. Beyond license renewal being key to you maintaining your practice, continuing education is essential to stay abreast of what is happening in your field – something your clients will always appreciate you taking seriously. Education is how we all continue to learn and further hone our skills and expertise, so it's certainly something to be celebrated. Though education is fantastic, keeping on track with the many hours you need to fulfill can be a challenge. Thankfully, there is a fantastic resource available to help you with that. Before we dive into the resource, let's start by outlining what is required of Montana LPCs in order to renew their license every cycle.

Licensee Requirements for Montana Licensed Professional Counselors

Montana licensed professional counselors have the same continuing education requirements as MFTs and LCSWs in the state. In the past, they have been singled out like psychologists, but they are now grouped together with their MFT and LCSW counterparts. LPCs in Montana must complete 20 hours of continuing education annually, two of which in suicide prevention. The remaining hours can be on any topic, so long as no more than 10 come from authoring a professional publication or preparing a new course. Otherwise, licensees can expect their continuing education to be approved if it improves their knowledge of professional counseling, it's relevant to current concepts and techniques, is directly related to counseling, and/or if it reinforces ethics and professional conduct. Note: licensees are subject to audits, so it is advised at least three years of continuing education certificates be maintained in the event they are requested by the board. Additionally, up to 20 hours can be carried over to the next year, should a licensee exceed the required 20.
